Dear Committee Members,

Please find attached the December 2020 Monthly Police Activity Report. It should be noted that along with our enforcement activities, there were also several events and tasks completed that accounted for our officers' time.

In addition to their regular duties, our patrol division continued to complete many requests for firearms permits, records duties, OPRA requests as well as six of our more senior patrol officers completed the Field Training of our three newest officers under the watch of Sergeant Shatkin and in compliance with state mandates. These new officers demonstrated dedication and professionalism and through their efforts, removed (3) illegal handguns and (3) illegally possessed rifles from individuals as well as numerous distribution of narcotics arrests during the month of December.

The detective bureau continued to assist patrol and fulfill numerous requests for discovery in addition to their investigative duties as well as prepared a training manual and search warrant database, both a first for this agency which will be used for the incoming detectives taking over the investigative duties.

On the administrative end, I continue to pursue ways to make the department run more efficiently and will be providing this committee a year-end report as well as a 2021 budget proposal. We continue to seek accreditation and work with the fleet management system in my endeavor to bring the department into compliance with the Attorney Generals guidelines and provide an insurance and cost savings to the township. We will be advertising for per diem dispatchers as another way to supplement staffing at a reduced cost to the salary portion of the municipal budget.

Productivity continues to increase as our officers work to enforce the traffic and criminal laws to protect and serve our residents as well as we launched our update website [www.rochelleparkpd.org](http://www.rochelleparkpd.org) to allow for more interaction and transparency with those we proudly serve.








### Ticket Count by Statute


