Dear Committee Members/Appropriate Authority,

Please find attached the January 2021 Monthly Police Activity Report. It should be noted that along with our enforcement activities, there were also several tasks that accounted for our officers' time.

In addition to their regular duties, the patrol division and supervisory staff handled many other activities to include random drug testing of employees, annual BCPO reporting, scheduling and attending training classes, maintenance of the fleet, installation of traffic signs, updating broadband lists, evidence and records room(s) filings and updates and more.

The detective bureau conducted investigations that led to the identification of a fraud ring that purchased new motorcycles and vehicles using stolen identification and credit card information and saw the seizure of approximately \$20,000.00 in cash and criminal proceeds.

I remain very proud of the tremendous efforts being demonstrated by the professionals that I work alongside with, (as demonstrated by the attached numbers) and I see and hear about the positive interactions that occur with our partners and stakeholders throughout the township on a daily basis.

On the administrative end, I have continued to work with my leaders from the top to the bottom of the chain of command and we are completing many of the goals set forth in our strategic plan and mission statement that continues to drive us and are available along with many other tools for our residents via our website. <a href="https://www.rochelleparkpd.org">www.rochelleparkpd.org</a>

Additionally, I have begun to look at ways of saving the township money, with the use per diem dispatchers as well as conducted a study of the enforcement actions taken by the police department over the past 13 years and their impact on the township budget.






