Dear Committee Members/Appropriate Authority,

In addition to their regular duties, the patrol division and supervisory staff handled many other activities including continued growth of the website and online resident portals, scheduling and attending training classes, fleet maintenance, meetings with vendors regarding Body Warn Cameras, updating our Mobile Vehicle Recording software / servers, Verizon phone systems and CRG in reference to school safety planning; interviewing of potential per diem dispatchers, evidence and records room(s) filings and updates and more.

The detective bureau conducted several investigations that led to the identification of a suspect of two stolen vehicles from a local car dealership and completed extradition paperwork to bring the suspect back to New Jersey from New York City after the suspect was arrested in one of the vehicles in Queens, N.Y. Our bureau along with some patrol officers assisted Hackensack P.D. with the execution of a search warrant in a joint investigation of a local cocaine distribution ring that was a direct result of one of our patrol officer's arrests.

Once again, the quality of work being done by our personnel remains at a very high level and the efforts being put forth is among the very best in the county and state as evidenced by the compliments and comments I have received several compliments from other Chief's and police officers about the professionalism demonstrated by our members.

On the administrative end, we have continued to obtain and provide training for our team at no or very little cost to our taxpayer and seen the benefits firsthand. Interviews of per diem dispatchers were conducted and we are moving ahead with the hiring process which in turn will save tax dollars when we have trained professional communication operators on the desk without having to pay overtime and allow for officers to be on the road. We also honored several officers with commendations for their extraordinary work at the public meeting on February 24, 2021.

I remain proud and humbled to lead this department and look forward to the departments continued movement forward and continued community involvement in the coming months.






