Dear Committee Members/Appropriate Authority,

In addition to their regular duties, the patrol division and supervisory staff handled many other activities to include an average of approximately (60) hours of training, the conversion from Nixle to RAVE Mobile, (text ROCHELLEPARKALERT to 67283), safety drills with the staff of Midland School, academy instruction of the police recruit class, and community outreach programs including expansion of fundraising for the L.E.A.D. program and donations to the R.P. Little League and Midland School 8th grade yearbook and working alongside R.P. Recreation for the Easter Egg/Bunny event and the R.P.F.D. Easter Bunny parade.

The detective bureau conducted several investigations that led to the identification of a suspect involved in an armed robbery at a local convenience store as well as several others around the county. Our bureau along participated in a joint investigation with the Fort Lee and Paterson P.D. involving a local grandparent/bail scam that resulted in an operational take down and an arrest of a suspect. They continue to follow-up on the fatal motorcyclist crash attempting to locate the tractor that left the scene.

Once again, the quality and quantity of work being done by our personnel remains at a very high level and the efforts being put forth is among the very best in the county and state and their work, including getting (2) kilos of pure cocaine off the streets and working with the Prosecutor's office Narcotics Squad in an interstate distribution ring has been noticed throughout law enforcement circles.

On the administrative end, we have hired and began the training of our per diem dispatchers. In addition to attending RPOEM meetings and a hot wash, filing monthly, quarterly reports and meetings with the A.G., Prosecutor's Office, I have started my New Chief's Orientation Training and the Captain conducted an auction of property from the police department that resulted in approximately \$10,700.00 in sales/revenue.

I remain proud and humbled to lead this department and look forward to our team's continued movement forward and community involvement in the coming warmer months.


