Dear Committee Members/Appropriate Authority,

In addition to their regular duties, the patrol division and supervisory staff handled many other activities to include but not limited to (8) eight hours of semi-annual firearms requalification, use of force simulator training as well as mandated online Law Enforcement and the LGBTQ+ Community training from the New Jersey Attorney General's office. The supervisory staff also continued to perform their duties as it pertains to community outreach programs, fulfilled OPRA and Records requests, maintenance on the C.A.D. system, Radar training, CPR training and had several meetings with Body Worn Camera vendors in preparation for the roll out of the BWC's.

The detective bureau continues to conduct investigations into past and current criminal activity around the township including several thefts of property and by extortion as well as handle Discovery and Expungement Requests for the Municipal and Superior courts.

Yet again, despite all of the other duties and required training time, our team continues to operate at the highest level and their effort being put forth is among the best in the county and state as you will see in the numbers attached within this report.

Our traffic division conducted the survey of Becker Avenue and based on the data officers have been assigned to conduct radar enforcement during the time periods where there was a noticeable increase in vehicular volume and speeds recorded.

On the administrative end, we continue to issue updated policies and procedures as well as conduct continued enforcement and training on those policies. Our officers have taken advantage of the unprecedented amount of training for the officers at no cost to the taxpayer and have used that knowledge to better their service.

I remain proud and humbled to lead this department and look forward to our team's continued movement forward and community involvement and interaction.

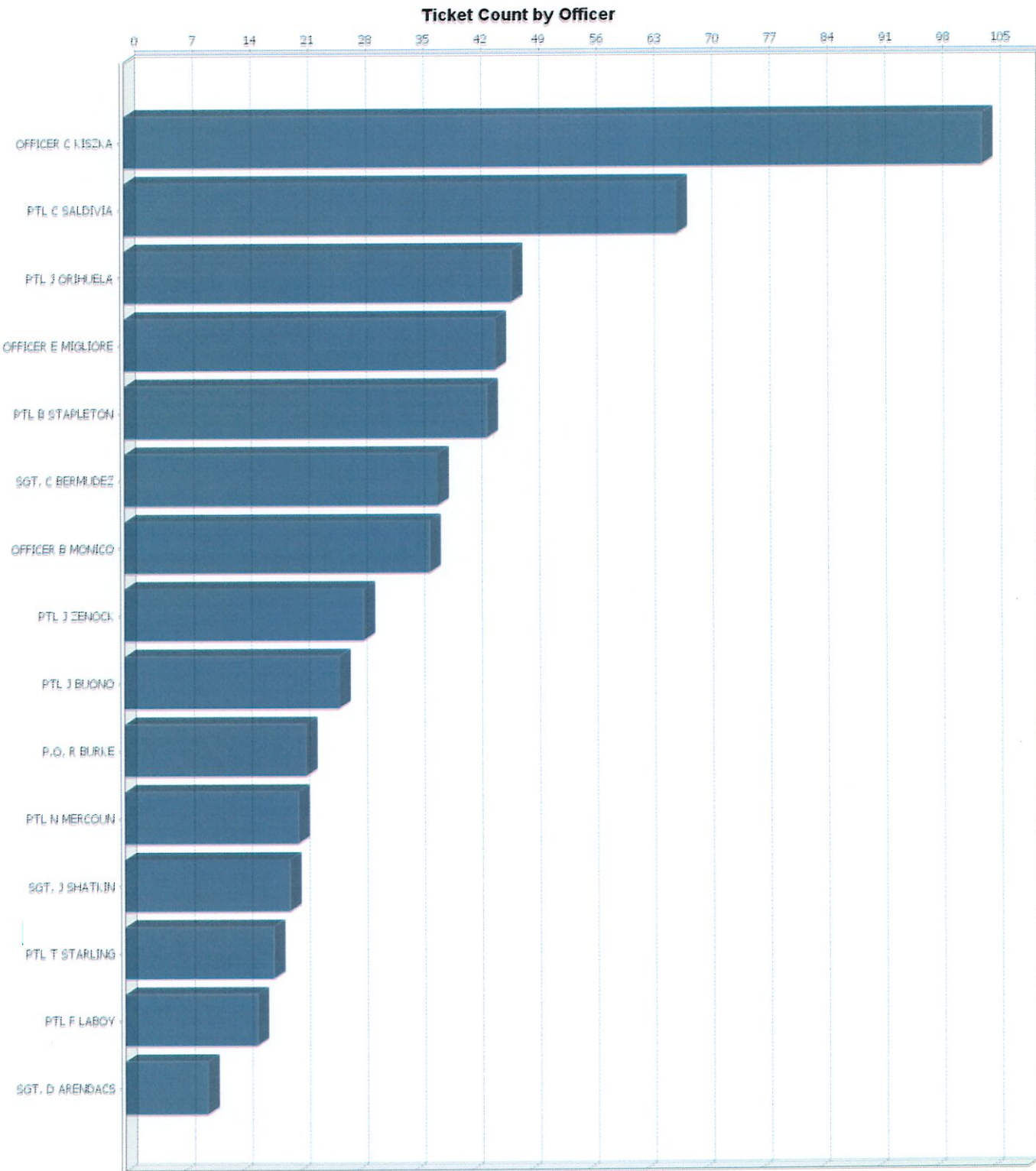

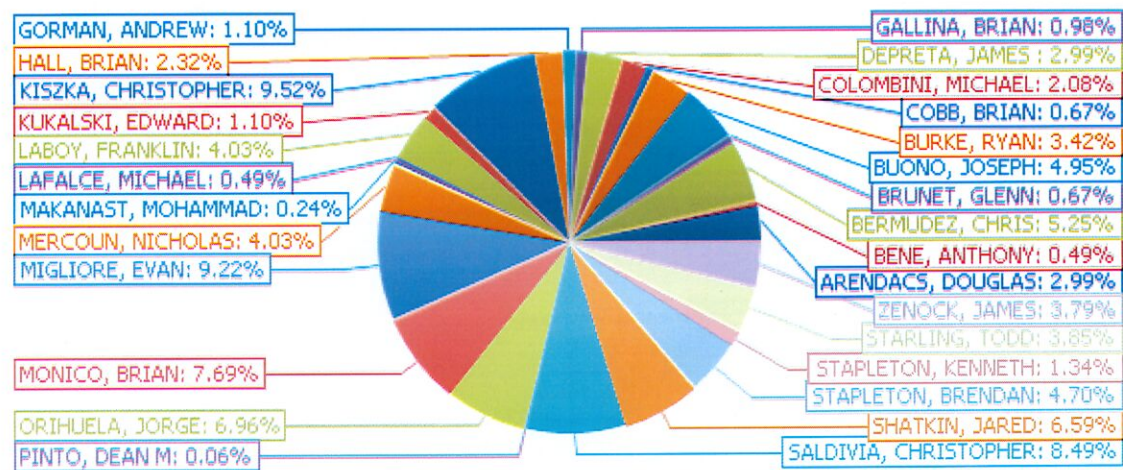
