In addition to their regular duties, the patrol division and supervisory staff handled many other activities to include but not limited to (16) sixteen hours of rifle familiarization and qualifications training that will provide half of our first responding units with the additional safety of a long gun in the event of an active killer situation. The supervisory staff also continued to perform their duties as it pertains to community outreach programs, fulfilled OPRA and Records requests, maintenance on the C.A.D. system, preparation of the online Overnight Parking Module and coordination of safety plans for Movie Night and the Midland School graduation.

Furthermore, our Sergeants completed with their Quality of Life details that offered varying type of law enforcement functions but with each delivering top notch service to the township, it's residents and the agency as a whole.

The detective bureau continues to conduct investigations into past and current criminal activity around the township including several thefts of property and by extortion as well as handle Discovery and Expungement Requests for the Municipal and Superior courts.

Yet again, despite all of the other duties and required training time, our team continues to operate at the highest level and their effort being put forth is among the best in the county and state as you will see in the numbers attached within this report.

On the administrative end, we continued to foster a sense of team pride and provide for more training that has a tenfold return on the minimal investment back to our department. I attended a L.E.A.D. fieldtrip to the NJ Jackals, the L.E.A.D. 




