Dear Committee Members/Appropriate Authority,

Unfortunately, September started off with "Hurricane Ida" and the flash flooding and subsequent river flooding that negatively impacted a large portion of our community. Luckily, my team was up to the task and were part of the Emergency Services team that performed 71 water rescues during the flooding event.

The officers and civilian staff of the police department stepped up their efforts during the height of the storm and raging flood waters and made sure that NOT one call was missed or one life lost. Our equipment was pushed to the limits and our former military five-ton high water rescue vehicle was crucial in making sure that these goals were met.

The detective bureau once again continues to conduct investigations into past and current criminal activity around the township and most recently uncovered a multi-state unemployment fund fraud that exceeds over \$150,000

On the administrative end, we continued to see the return on investment in the trust of responsibility in our team members. They continue to work hard and put the very best of themselves in projects large and small. We also have been preparing to provide each officer with about 40 hours of mandatory training before years end that has come down from the Attorney General and Prosecutor's office.

It should be noted that the performances of the officers during the storm and in the days afterwards is nothing short of heroic. I look forward to sharing some of these stories at the public meeting.

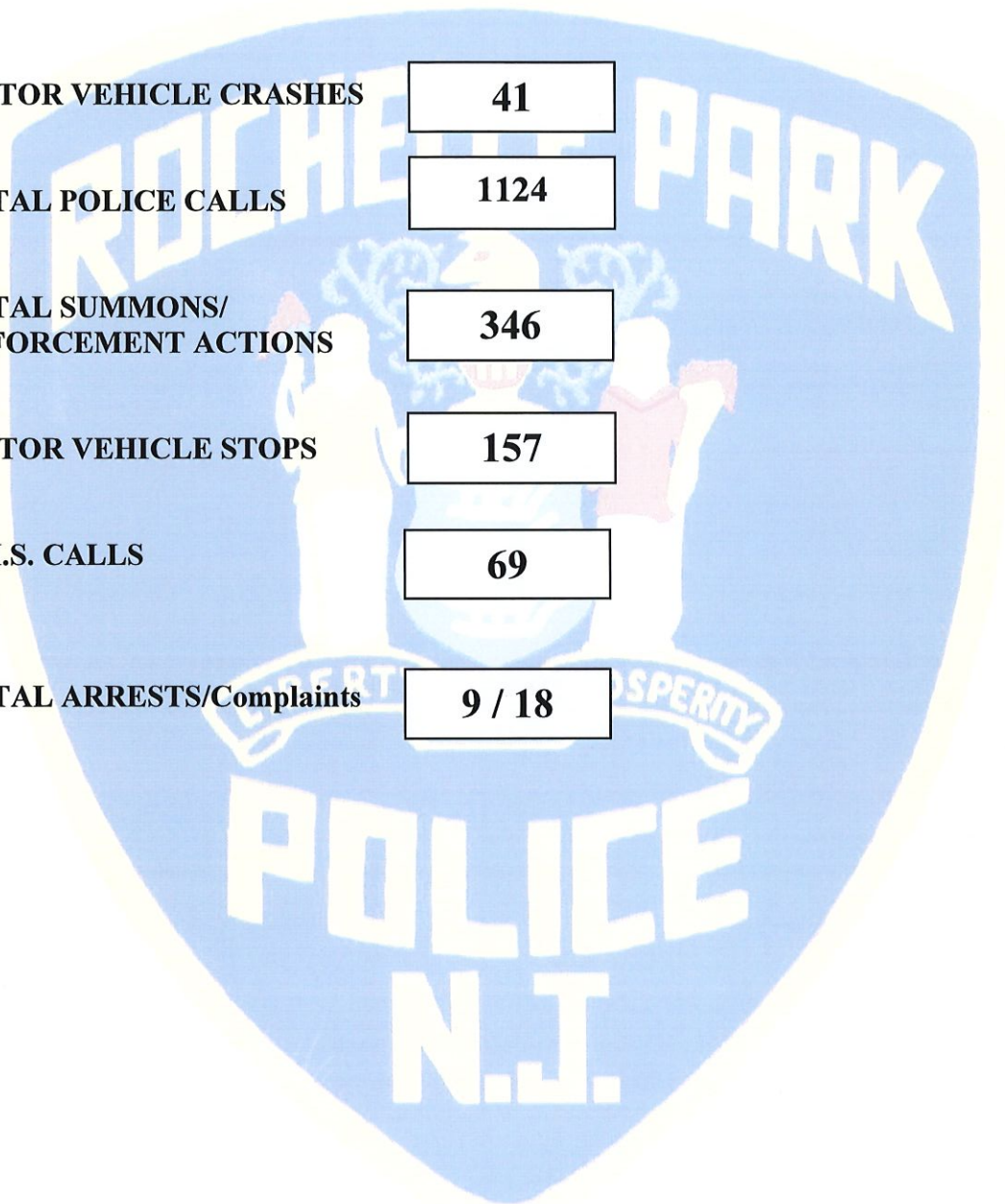

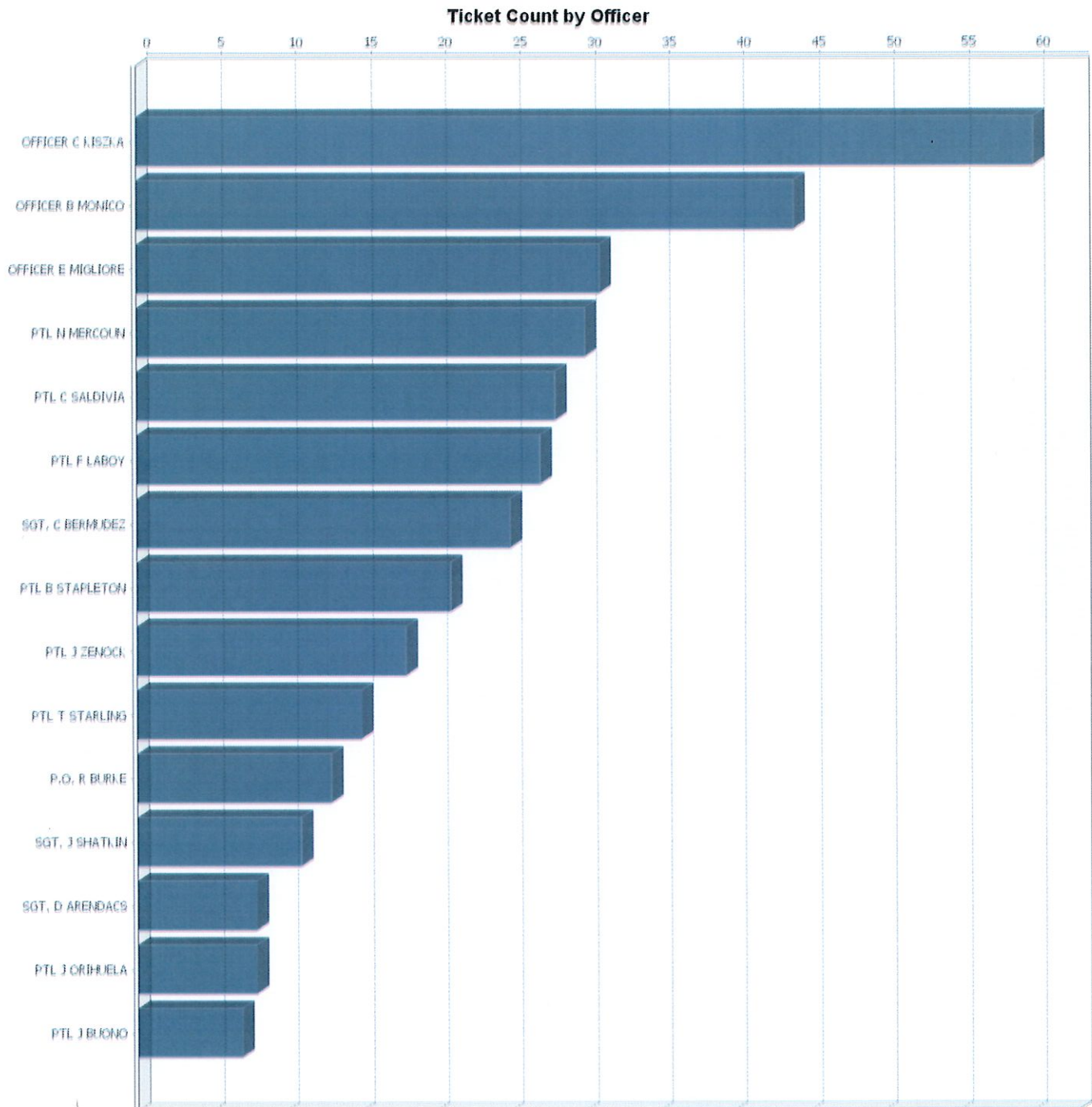

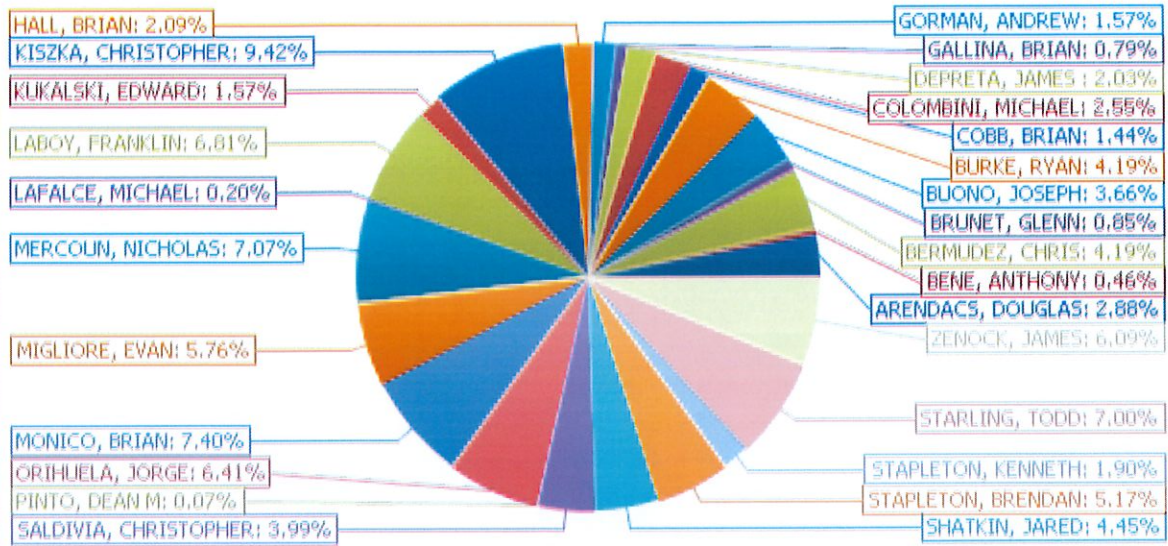
