Dear Committee Members/Appropriate Authority,

The month of November once again was a busy one for the members of the Police Department. Our team continued to protect and serve and enforce the motor vehicle and criminal laws in our endeavor to keep our residents and town safe.

In addition to the many mandated hours of ICAT and ABLE training (de-escalation and preparation of officers to teach them how to successfully intervene to prevent harm and to create a law enforcement culture that supports peer intervention, officers also had to complete 8 hours of updated Use of Force training from the Attorney General's office.

The detective bureau once again continues to conduct investigations into past and current criminal activity, helping solve and arrest robbery and homicide suspects. Additionally, they have also been working on a multi-state fraud case that has the potential for a seizure of financial assets.

On the administrative end, we continue to work on ways to better serve our residents and have recently completed the necessary incorporation of the Rochelle Park Police Foundation, Inc. which will be a 501 (c)(3) that will allow for the police department to give back to the community on unprecedented levels.




Ticket Count by Officer


