From all of us here at the department, I want to take a moment to wish everyone a Happy New Year. I hope that this finds everyone doing well, and staying healthy.

2021 was a better year overall, but it didn't come without its own issues, such as the devastating impact of Hurricane Ida and unfortunately COVID-19 has come back and something that we continue to talk about. Hopefully in the upcoming year, it will fade, be classified as an endemic and we can move on without it overshadowing all that we do.

Last year was one of unprecedented changes in terms of policy and legal revisions, procedural updates, Attorney General Guidelines, and county directives. The officers trained more in 2021 than ever, ranging from the Use of Force, Pursuit, De-Escalation, Resiliency, Marijuana / Juvenile Reform, as well our own internal requirements that we promoted to keep us on top of our game. We were able to hold our very first National Night Out and take part in community outreach programs that has strengthened our relationship with those we are sworn to serve and protect. We also are on track to have our full body camera program up and running in the beginning of 2022. While the officers already have car cameras and body mics, they are looking forward to the new system as experience has proven that the video will show what the officers go through and will continue to show their professionalism and how really great they are at what they do.

We continued to have so much support from people within the township, who believe in our mission and appreciate the officers and the way they take care of things. It is truly a gift for our officers to know that the community supports them as it helps tremendously and puts meaning to all they endure. When my officers are struggling over the call they just went on, or the tragedy they just witnessed and had to handle, or the violent interaction with some criminal who tried to do everything they could so my officer wouldn't make it home after their shift, having that support in the back of their minds means the world to them. In our continued effort to be a larger part and give back to the community, the Rochelle Park Police Foundation has been incorporated and will be helping our members of law enforcement, their families and the community at large as a charitable organization.

Our officers truly went above and beyond this past year as is evidenced by the numbers listed in this Year End Report, but to highlight some of the increases over past years: We handled over 13,000 call types with 27 Firearms/Weapons Arrests, 178 Adult Arrests, 147 Narcotics Offense Arrests and 5,444 motor vehicle summonses issued. These numbers far exceed any one-year total that I can remember during my time since 1990 as a Rochelle Park police officer.

I want to thank all the emergency services in town. Our Fire Department, Office of Emergency Management and CERT members and all of the township entities such as the D.P.W., Administrative Offices, Building Department and others who work side by side with my officers taking care of our residents.

Thank you to all the community groups, American Legion Post 170, Boy Scout Troop 114, Knight of Columbus Council 2842 and Midland School who work constantly with us to ensure a safe environment for our children. The way everyone in this town comes together is a testament to everyone who works, lives, and volunteers here.

I apologize for anyone I missed, but please know I appreciate all that the town and the people we serve, do for us. As we enter into a New Year, I hope everyone can take a moment to appreciate those who are out there working day and night to protect and take care of the community, from police, to fire, to ems, to our military, and think about those who never made it home from their tour of duty, regardless of the profession.

I hope that all of you can have a happy and healthy 2022 and join us in celebrating our 115th year of protecting and serving you. We remain here, ever vigilant, to serve and protect you. My officers are second to none, and the pride I have in them, the department, and the job they do is without measure. They truly are the best and you can feel safe with them on watch.








