Dear Committee Members/Appropriate Authority,

The month of December kicked off with the police department showing more of our community outreach savvy. We were grateful to be partnered with the recreation committee for the township's tree lighting ceremony that drew a crowd approaching 500 people with as many smiles present during our police escort of the horse and carriage rides, the collection of toys and providing food and hot chocolate for those in attendance, all the while keeping everyone safe.

December also continued to be a busy month as our team continued to protect and serve and enforce the motor vehicle and criminal laws in our endeavor to keep our residents and town free from criminal activity.

Additionally, our officers continued to attend training of ICAT, ABLE, CIT training (de-escalation, crisis intervention and preparation of officers to teach them how to successfully intervene to prevent harm and to create a law enforcement culture that supports peer intervention), officers also had to complete their semi-annual firearms requalification.

The detective bureau once again continues to conduct investigations into past and current criminal activity, and have steadfastly worked on developing leads and suspects in some of the recurring property crimes that have taken place and work with our residents on solving quality of life issues.

On the administrative end, we continue to work on ways to better serve our residents and have been working with a vendor to receive free services via our Resident Portal and have begun to build out our website for the Rochelle Park Police Foundation, Inc. which will be a 501 (c)(3) that will allow for the police department to give back to the community on unprecedented levels.
