Without a moment's hesitation, he rolled up his sleeves, located the hidden spare tire, un-bolted the tire and we were off in no time at all.

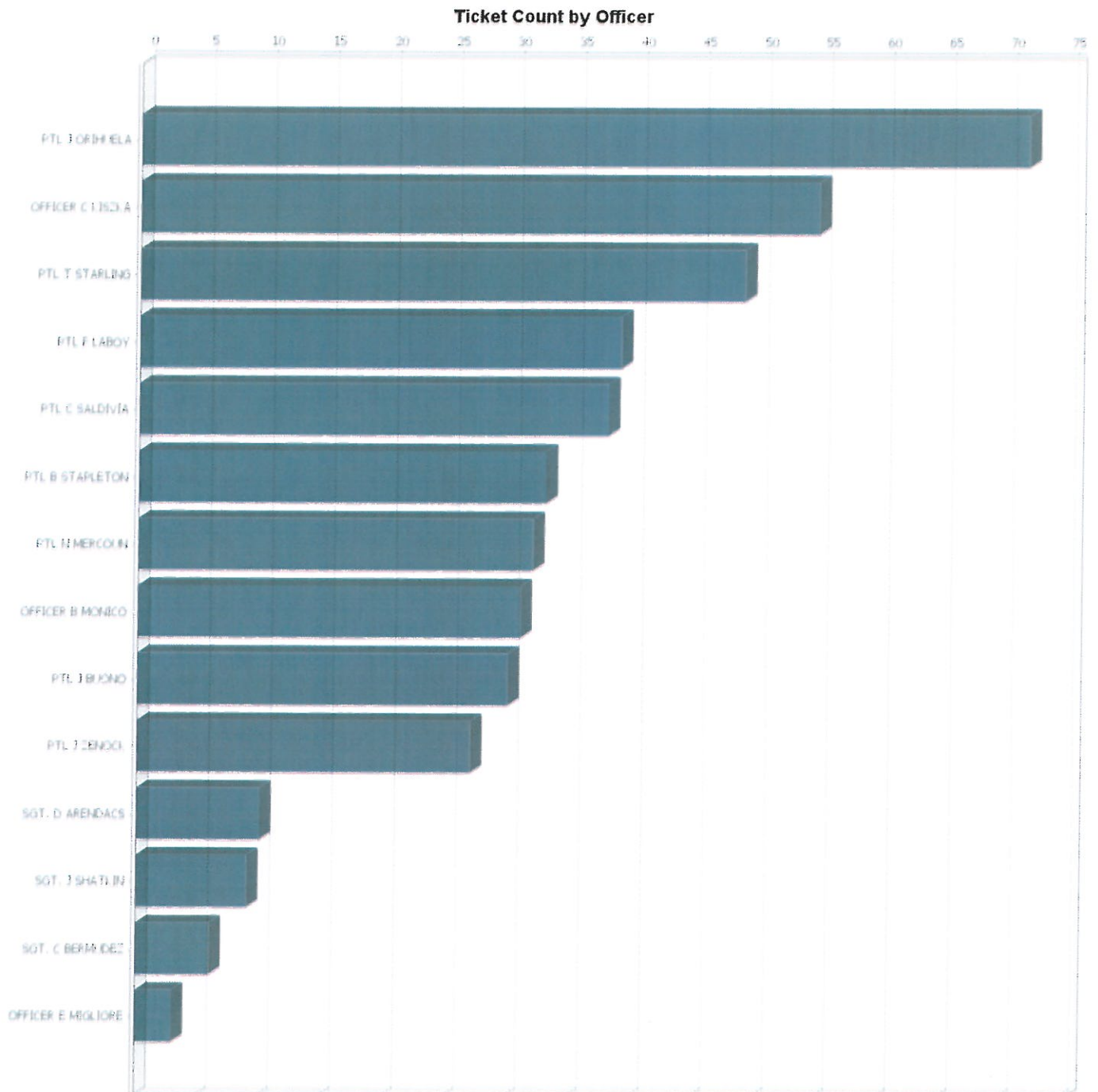

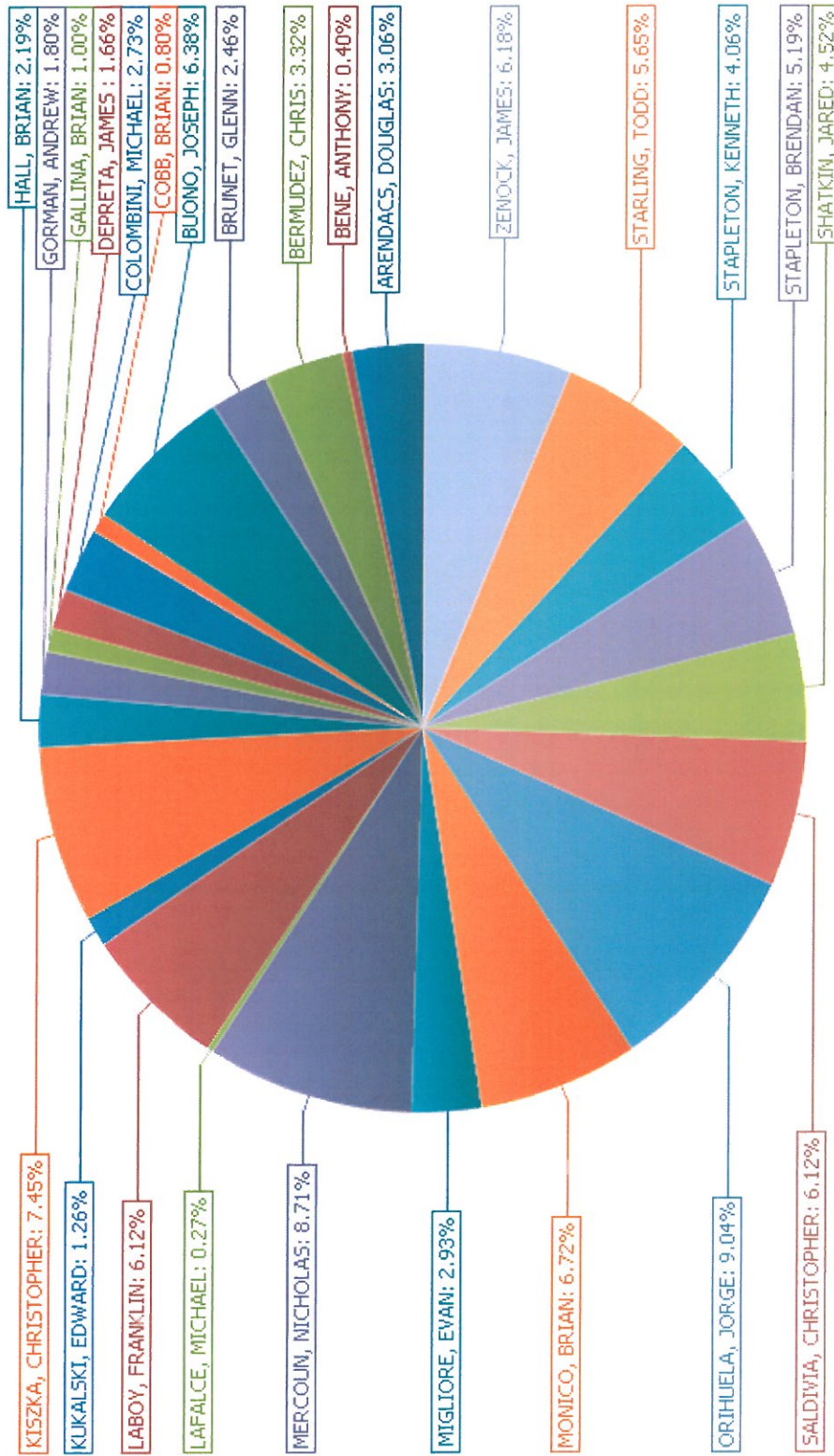
