During the month of April our team answered the **962** calls for service in the professional and courtesy manner we have grown accustomed to. The department also continued to perform our community relations and outreach with a focus on Autism Awareness during the month. Officers donned specially made and approved baseball caps, police patches along with "merch" that displayed our awareness and pride in helping our citizens who are on the spectrum.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests and summonses issued.

The detective bureau continues to conduct investigations into past and current criminal activity, and has been working alongside patrol in the combined effort to keep our residents safe as well as working on the expungements of thousands of marijuana cases.

On the administrative end, we continue to work with the governing body and administrative offices to work on improving our efficiency as we also push for training opportunities that will pay itself back in dividends to the township and the department and all of our stakeholders on the service they receive. During spring break, our team participated in more of the required "active killer/shooter" training at Midland School and this not only prepared our frontline officers, but helped our command staff develop improved policies.

Lastly, we continue to work with the county of Bergen, our juvenile officers and school district to develop plans that foster a better relationship with our community's juveniles in a way that comports to the new state and county mandated juvenile reforms, yet allow for our adult residents to live without feeling threatened by roving groups of young people on their bicycles or who trespass with the intent to act in a disorderly manner and disturb the peace.




