During the month of June our team answered the **1125** calls for service. The department also continued to perform our community relations and outreach with our sponsorship and attendance at the Special Olympics Torch Run, L.E.A.D. Kindergarten graduation, the L.E.A.D. baseball game field trip, and the Midland School Graduation.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (15) and summonses (267) issued. The unprecedented amount of training continued with Sergeants Bermudez and Shatkin completing the FBI LEEDA Command Leadership class, Detective Gallina finishing the (6) six day intensive TOP GUN training offered by the New Jersey Attorney General's Office and we are already seeing it in action and its positive impact on team members here in the P.D.

Administratively, Lieutenant DePreta closed out the project from Tropical Storm Isaias that will help obtain \$38,000.00 in FEMA money back for the township. Lieutenant Kukalski worked with the traffic bureau and the DPW in mounting several signs that will help monitor and provide warning to motorists in our endeavor to make the roadways in RP safer. I attended the New Jersey State Association of Chief's of Police Conference and met with several vendors that will be able to provide services to the township that will save taxpayer dollars and help us continue to move forward and provide a better level of service for our residents.

As a reminder, on August 2, 2022 at Midland School from 6pm to 9pm, we will be hosting our National Night Out and will once again have our partners from the Fire Department Office of Emergency Management present along with several county agencies and an assortment of Food Trucks. We also added face painting and a dunk tank to go along with our punt, pass and kick contest this year and the debut of our new Patrol Services Pickup truck.




