During the month of July our team answered the **1064** calls for service. The department also continued to perform our community relations and outreach and worked with the Paramus Police Department on providing traffic and security for their fireworks display.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (9) and summonses (186) issued.

Administratively, we saw Lieutenant Kukalski complete the FBI-LEEDA Executive Leadership Institute and our team complete the mandatory ICAT/ABLE trainings. Our leaders have continued to prepare for the upcoming school year by issuing policy and orders pertaining to the newly created school resource officer position and have reviewed the applications for new police officers and scheduled interviews for those moving on in the process. We continue to manage and move on from the fire in headquarters in June and flooding damage created in July's rain storm.

We have also continued to work with the school district on the changes and upgrades in the traffic pattern and child drop off area at Midland School for the upcoming school year. We have continued to partner with the DPW and developers on upgraded traffic improvements and speed mitigation painting and signage around town.




