During the month of August our team answered the (1012) calls for service. The department also continued to perform our community relations and outreach and had another great National Night Out event to kick off the month!

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (12) and summonses (290) issued.

Administratively, we saw Detective Sergeant Bermudez attend an in-person Crisis Management for School-Based Incidents, and Partnering Rural Law Enforcement, First Responders and the Local School Systems via Zoom. Lieutenant Kukalski updated and installed radar units in our fleet. Our leadership team of Captain Brunet, Lt. DePreta, Sgt. Stapleton, DSgt. Bermudez, Sgt. Shatkin, Det. Cobb and I conducted interviews of applicants for new police officers and began to conduct background checks on those who will be offered the position.

Sergeant Shatkin and Officer LaBoy proudly and honorably represented our department at the Hackensack Police Youth Academy, with Officer LaBoy once again being voted the best instructor by the students. Our team also worked with the R.P. Recreation / Day Camp and participated in "touch a truck" and the coordination and landing of a New Jersey State Police helicopter.

We continue to manage and move on from the fire in headquarters in June and flooding damage created in July's rain storm and await the contractor(s), ServPro and our insurance provider to begin the work to restore our space back to normal.




