During the month of September our team answered the (1268) calls for service. The department also continued to perform our community relations and outreach and we had our inaugural "first day of school" with our School Resource Officer Detective Sergeant Bermudez, "Officer Chris". We also participated in helping with traffic during the first few days of school utilizing the new traffic pattern created by Lieutenant Kukalski with no issues and enhanced safety for all those who visit the school whether to park or drop off students, etc.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (12) and summonses (348) issued.

Administratively, we hired our two newest officers and promoted Franklin LaBoy to Sergeant:

Police Officer Hasan S. Shah, a proud graduate of the 2017 New Jersey State Police municipal class. Most recently P/O Hasan Shah worked for the Newark Police department. 


