During the month of October our team answered the (1156) calls for service. The department also continued to perform our community relations and outreach at the PTO trunk or treat event, the Ragamuffin Parade and gathering at Carlock Field afterwards as well as our officers drove around and provided treats to trick or treaters on Halloween.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (18) and summonses (275) issued.

Administratively, our two new officers are undergoing their field training under the requirements of the police training commission with our team members/leaders and they are both making great progress in becoming a part of the fabric of the RPPD.

Our officers also completed their mandatory use of force/vehicle pursuit training in conjunction with their firearms qualifications.

We have also updated members of the department with access to Spatial Data Logics through the collaboration with the Building Department which allows for them to report and monitor property maintenance and code enforcement in real-time in our endeavor to help improve the quality of life of our residents and stakeholders.




