Dear Committee Members,

During the month of November our team answered (1201) calls for service. The department also continued to perform our community relations and outreach at several events that are listed below.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests (10) and summonses (354) issued. The detectives have several investigations underway and have assisted in numerous arrests and complaints being issued.

Administratively, our two new officers have continued their field training under the requirements of the police training commission with our team members/leaders and they have already demonstrated their abilities and knowledge in being placed in their own cars and backed up on every call. Furthermore, P.O. Shah demonstrated his Newark P.D. experience during a Thanksgiving night burglary in which he and P.O. Monico performed a seamless search of the interior of a residence and took a male party into custody without incident.

Our School Resource Officer continued to conduct outreach details as well as he has become an integral part of the fabric of the school community allowing for the relationship between our township's younger population and the police department to thrive.

In late November, (3) three officers also performed a "quality of life" detail during which time they located many possible zoning, building, code violations and forwarded a (31) thirty-one page report to our Building Department, Fire Official and Code Enforcement team members to work collaboratively towards improving the look and feel of the town in the shared endeavor of moving the township forward.




