From all of us here at the department, I want to take a moment to wish everyone a Happy New Year and know that we remain yours in public safety! As the 10th Chief in the history the department I am beyond proud to share this with all of you as we completed our 115th year of service to the community of Rochelle Park.

While 2022 was much better for the township in that we did not suffer impactful major floods or pandemic related issues, we here in the RPPD did suffer a small fire, water leaks and subsequent damage that resulted in a modern “make-over” of our headquarters which has never looked so good!

Last year we rolled out our state mandated body worn camera program, continued to host our 2nd annual National Night Out and take part in community outreach programs, such as the return of “coffee with a cop”, “etch and catch catalytic converter program”, a quality of life detail that focused on property maintenance issues around the town and has helped launch a collaborative effort between the DPW, PD, FD, Construction Official and Fire Officials office. All of these will help to continue to strengthen our relationship with those we are sworn to serve and protect.

We continued to foster our community-based support and relationships and worked hand in hand with the board of education and township committee to launch our fulltime School Resource Officer program and add an additional officer to our roster. Our community outreach on social media and website grew with the return of our popular weekly police blotter. In our continued effort to be a larger part and give back to the community, the Rochelle Park Police Foundation has been incorporated and will be helping our members of law enforcement, their families and the community at large as a charitable organization.

Our officers continued to work hard in 2022 as is evidenced by the numbers listed in this Year End Report, but to highlight some of the stats: We handled over 13,000 call types with 30 DWI/Alcohol Arrests, 10 Domestic Violence Arrests, 99 Juvenile Complaints, 148 Adult Arrest, 5 Robbery arrests, and 3,640 motor vehicle summonses issued.

The detective bureau continue to investigate several major crimes that led to closing out a murder/suicide and several arrests including a Rochelle Avenue Armed Carjacking that led to suspects who were on a crime spree throughout the state, an investigation of a residential cocaine distribution center and arrested the resident, shutting down the operation, and also worked on a fraud case and uncovered a \$5,000,000.00 Multistate PPE Loan Unemployment Scheme.

We continued to expand our training for our team members with a focus on de-escalation and crisis intervention training among the many mandated trainings that we continue to do as well as provide a dynamic range of options for our team members in our continued effort to always be moving forward.

I want to once again thank all the emergency services in town. Our Fire Department, Office of Emergency Management and CERT members and all of the township entities such as the D.P.W., Administrative Offices, Building Department and others who work side by side with my officers taking care of our residents.

Thank you to all the community groups, American Legion Post 170, Boy Scout Troop 114, Knight of Columbus Council 2842 and Midland School (PTO/Board of Education) who work consistently with us to ensure a safe environment for our children. The way everyone in this town comes together is a testament to everyone who works, lives, and volunteers here.

I hope that all of you can have a happy and healthy 2023 and we look forward to another year of protecting and serving you. We remain here, ever vigilant, to provide the highest quality of service to our small-town. Our officers are second to none, and the pride I have in them, the department, and the job they do is without measure. They truly are the best and you can feel safe with them on watch.

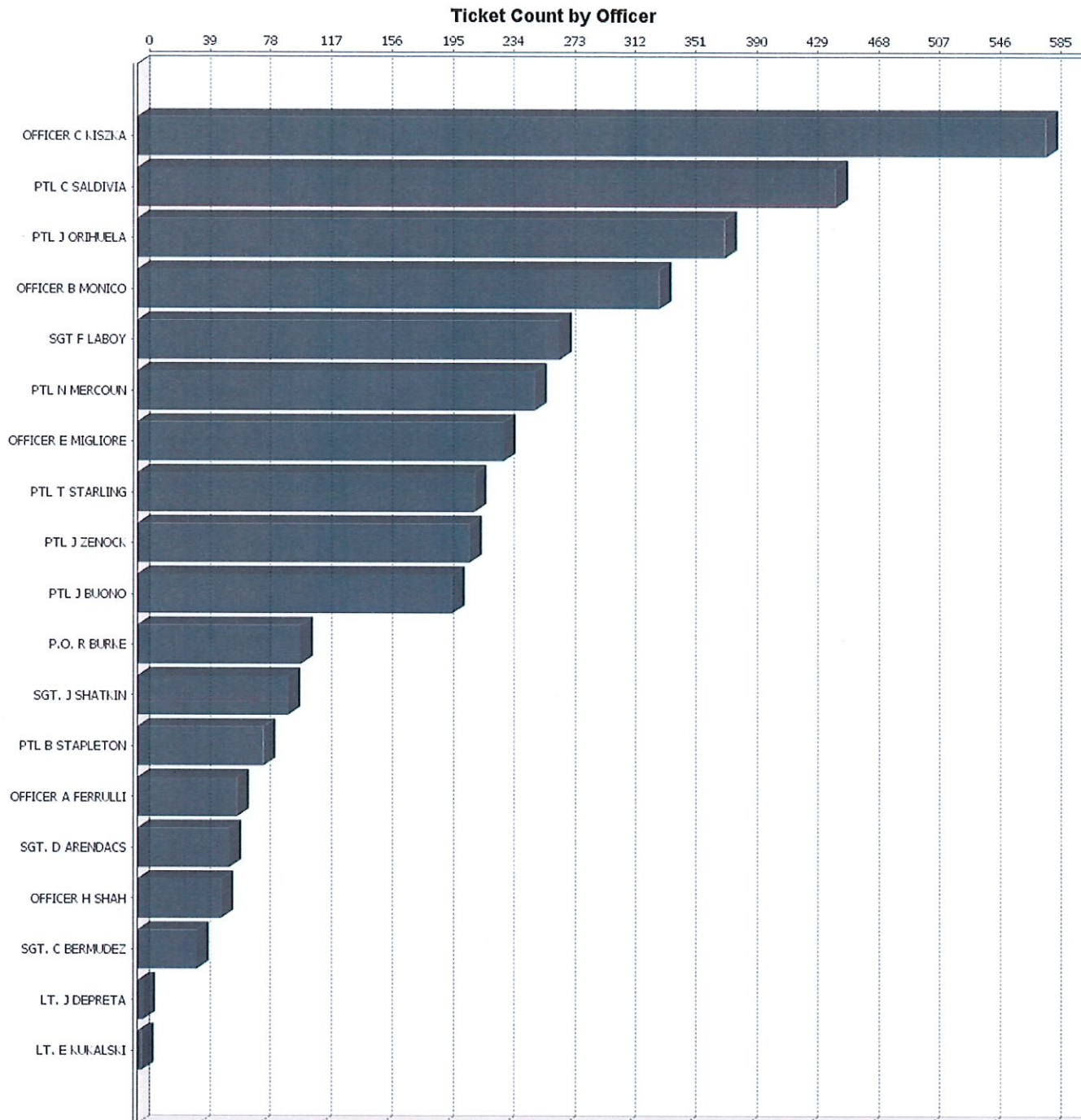


Ticket Count by Officer

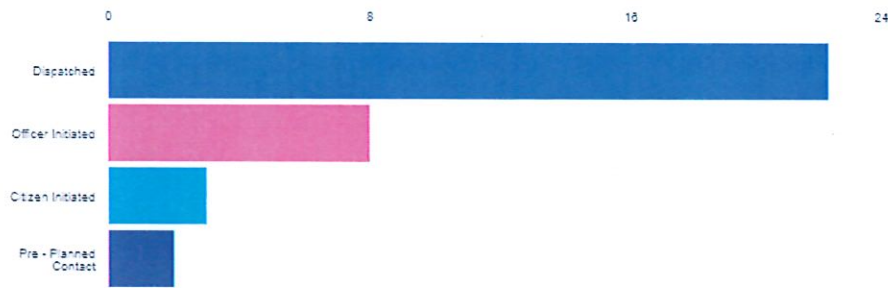

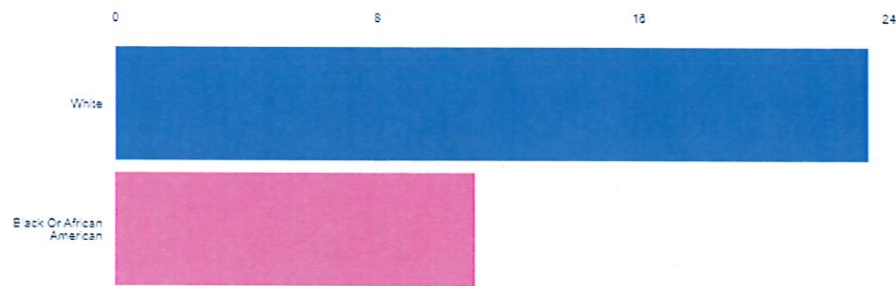

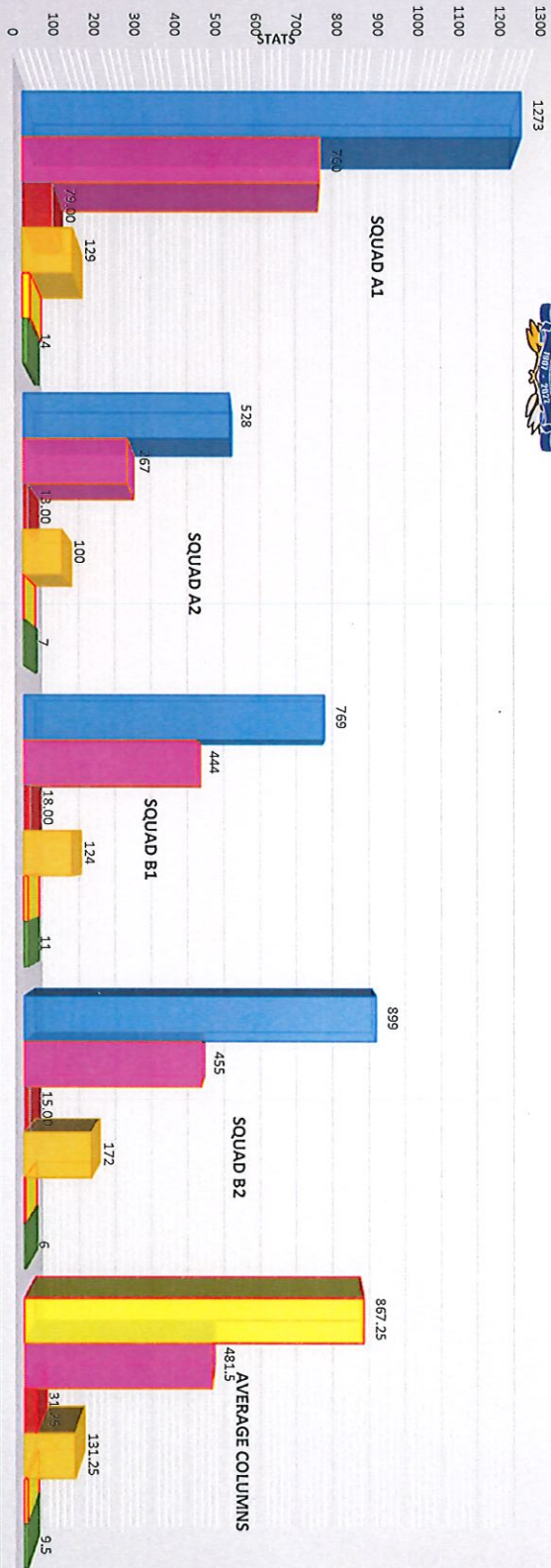
