During the month of November our team answered **(1042)** calls for service. The department also continued to perform our community relations and outreach at several events that are listed below.

Our team continued to demonstrate good proactive patrol tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and the output is demonstrated by the arrests **(10)** and summonses **(207)** issued. The detectives continue to investigate several crimes with multi-jurisdictional components and continue to assist in numerous arrests by patrol and helping with follow up complaints being issued.

Administratively, our team continued to provide safety and security to the township even while the world celebrated the holiday season. We continue to see progress in the training of our two newest officers who continue to impress and bring a new level of excitement to the job and they have been assigned to their respective squads.

Our School Resource Officer along with the Midland School PTO and our officers participated as part of the Santa's Response Team (SRT) in the Toys for Tots program loading and transporting (3) vehicles worth of donated toys to the drop off point where they were then distributed to children in need. We also participated and provided scene safety and a smores station for the township holiday tree lighting and helped coordinate the trolley rides as our relationship with the recreation committee remains strong.




