Dear Committee Members,

During the month of January our team answered (1234) calls for service. The department also continued to perform our community relations and outreach at several events that are listed below.

Our patrol officers continued to demonstrate good proactive tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and their output is demonstrated by the arrests (11) and summonses (433) issued.

The detective bureau continues to investigate several crimes with multi-jurisdictional components and continue to assist in numerous arrests by patrol and helping with follow up complaints being issued. Most recently, they began a joint investigation with the BCPO Financial Crimes Units in regards to a "spoofed" email scam in which our town victim was defrauded out of \$750,000. They interviewed all involved parties and multiple subpoenas were issued to several banking institution and as a result they were able to identify (3) potential suspects from Atlanta and St. Louis. Tracking the stolen funds, BCPO was able to freeze and recover \$450,000 for our victim. Additionally, they are hoping to get federal assistance from Secret Service to charge our suspects. The bureau also continued an investigation into a \$70,000 elderly scam victim. Multiple subpoenas and Freeze orders were issued to TD Bank and detectives were able to identify the recipient of the stolen funds, learning that party resides in Maryland where they contacted him and discovered that he too was the victim of the scam. It appears that the scam originates in India and fortunately they were able to freeze \$20,000 for our victim.

Administratively, our team continued to be provided many trainings that will be of direct benefit to our team and stakeholders. Several of these trainings came at NO additional cost to our local taxpayer through the many relationships we have grown over the years with our partners in federal, state, county and private training companies.

Our School Resource Officer continues to work towards bringing the community, police and schools together which has led to an overall "it takes a village" mentality in helping us tackle crime and with our crime prevention strategies in our small-town!




