Dear Committee Members,

During the month of March our team answered (1604) calls for service. Even with this high amount of calls for service, our patrol division and detectives continued to demonstrate good proactive tactics in the endeavor to seek out criminals and criminal behavior before it impacts innocent people and their output is demonstrated by the (205) motor vehicle stops, (15) arrests, (47) criminal charges and (517) summonses issued.

In the month of March, we also continued our community outreach and members of the department attended several youth basketball games to provide security and meet with parents and children. Captain DePreta, Lieutenant Stapleton, DSgt. Shatkin and Detective Mercoun participated in "Read Across America" at Midland School and Sgt. Cobb and P.O. Buono attended the Recreation Committee's "Easter Egg Hunt". The department continued our "Cops in Shops" program which profiles a local business with our officers meeting and greeting the ownership/management and introducing the police department to them and profiling this on our social media platforms.

The department continued to expand the capabilities of our team with training in many facets of the job including Sgt. Gallina attending Crisis Intervention Training, P.O. Kiszka became a state certified Drug Recognition Expert, our detectives attended financial crimes training and the entire department completed their mandatory yearly rifle training.

On the administrative side, we continued to expand our recruitment effort through advertising and on the PoliceApp platform which is an online application and recruitment system designed for police departments and law enforcement job applicants. Based on the national and statewide downward trend in police applicants, we are expanding the deadline for applications to April 22, 2024.




